
# MSC AUTO RENEWALS

We are releasing a new feature with functionality around renewals. The goal is to help inform your customers of upcoming renewals. An automatic DocuSign contract with the same range, term and supplier will be sent to the customer.



As default, the auto-renewal email will be sent 90 days in advance, 60 days in advance, 30 days in advance, on day of expiration, and 30 days after

expiration. ESP Brokers can customize to send to all of these options, or remove any of the interval frequency. They will simply need to just ask their Account Manager to customize this on their behalf.



What if my customer already renewed through ESP? The system will recognize this, and the auto-renewal emails will not be sent.

### Will my customer receive a reminder email?

Yes, only 1 time three days after the original DocuSign was sent.

### Will I be copied on the email?

Yes, the broker will be CC'd.

# What if I already sent a renewal contract to my customer?

If a broker generates a renewal proposal anywhere in the process between 90 and -30 days, the auto renewal will not be sent for 30 days. This allows the broker 30 days to renew the contract that he or she provided to the customer.

# What if the customer dropped?

An auto-renewal email will NOT be sent.

# Once it has been renewed, will the emails continue?

No, once renewed, they will not receive anymore.

## Will the contract stay in there forever even if they are not signed?

After 90 days, if there is no signature, it will be deleted from MSC. Also, once signed, all other renewal attempts will be deleted.

# When will the DocuSign expire?

It will expire 30 days after being sent, therefore the customer has 30 days to sign.
